Dear Parents

Year 7 Enrichment Week: 26th June to 29th June 2018

This letter explains the activities taking place during our Enrichment Week when students enjoy a programme of enrichment and extracurricular activities both in and out of school. Music instrumental lessons will be held as usual during Enrichment Week and girls should see their teachers in advance if they are out of school and it is necessary to rearrange the time. As you will see from the dates, extracurricular activities begin on Tuesday 26th June. Monday 25th June will have usual lessons in the morning and Sports Day in the afternoon (weather permitting).

The specific arrangements for all trips will be sent out nearer the time.

The cost of all the trips includes transport, entrance fees and tuition. Visits are dependent upon the generosity of parents making a contribution towards the cost. The school has subsidised the cost of these trips and therefore we are now asking for a contribution of **£50** per student to enable these activities to go ahead. Payment and consent should be made via ParentPay. When you pay for these activities on ParentPay you will be required to tick the box to give consent for your daughter to join the trips. You will also need to fill in the notes section with an emergency contact number, and details of any medical conditions of which we should be aware. If you are unable to use ParentPay please contact Mrs Kennedy, our Finance Officer. All school trips are subject to the School's Code of Conduct, which I would request you bring to your daughter's attention. A copy of the School's Code of Conduct can be found on the school's website; Parents and Students tab; Trips and Visits. **The deadline for payment and consent is Thursday 29th March 2018.**
